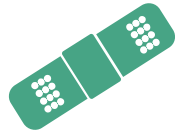

REQUIRED PACKAGING INSTRUCTIONS

- USE PROVIDED RED BAG
- SECURE RED BAG BY TWISTING AND HAND TYING INTO A SINGLE KNOT TO ENSURE CONTAINMENT OF THE MEDICAL WASTE
- CLOSE AND TAPE TOP AND BOTTOM FLAPS WITH 2 INCH WIDE PRESSURE SENSITIVE TAPE
- IMPROPERLY PACKED CONTAINERS WILL BE REJECTED FOR REPACKING (LEAKING, OVERFLOWING, LOOSE SHARPS, IMPROPERLY LABELED, ETC)

BOXES MUST NOT EXCEED 45LBS. OVERWEIGHT, DAMAGED, LEAKING, OR INCORRECTLY PACKAGED BOXES MAY BE DENIED PICK UP OR RESULT IN ADDITIONAL FEES.
